1. Introduction

The TAG Terms of Reference make provision for the formation of Technical Working Groups (TWGs) and Ad-hoc Advisory Groups (AAG) to support the technical and scientific work of the TAG. Typically, both a TWG and an AAG will be comprised of technical experts external to ASC’s governance bodies with a member of the TAG acting as sponsor to facilitate communication and understanding between the TAG and the TWG or AAG and support the ASC technical lead. ASC’s Secretariat will provide logistical support to the group(s) and a technical coordinator from ASC will be appointed to provide the group(s) with the technical resources. This may include a white paper to initiate discussion and a draft Standard following TWG deliberations. An external facilitator may be appointed for complex topics. The difference between a TWG and AAG is that the AAG has a narrower focus and often operates in a shorter timeframe.

2. Terms of Reference

This document describes the terms of reference of a Technical Working Group (TWG) for the introduction of the topic of human rights into the ASC Chain of Custody (CoC) module.

2.1 Statement of purpose

The purpose of this **Technical Working Group (TWG)** is to support the development of human rights elements in the ASC CoC Module.

2.2 Scope and aims

ASC envisages an aquaculture sector where employees and communities have a decent quality of life. It is our mission to respect and promote the human rights of those who work in aquaculture, or living in surrounding communities, and improve their wellbeing. We aim to act as a catalyst for broader, industry-wide change.

Approximately 22 million people are employed in the aquaculture sector. The FAO has recently started collecting data on how many are employed from the time a product has been harvested to when it has been delivered to a customer. Across 52 out of 223 reporting countries and territories, there are 1.7 million people employed in this work¹.

While ASC's Farm and Feed standards include comprehensive human rights requirements, ASC has not yet introduced similar requirements into its Chain of Custody standard.

Seafood processing and packing carries a wide range of risks to workers' wellbeing. In line with ASC's commitment to respect and promoting human rights of those who work in aquaculture, ASC is developing a system to expand its human rights' work along the supply chain, of which the TWG is a component.

The TWG will be assigned the following tasks:

- Provide advice on the approach for how to introduce human rights into the ASC CoC Module in a robust and feasible way.
- Evaluate the risks associated with the different proposals, the possible impacts on ASC's stakeholders, and the feasibility of different options.
- Provide guidance on the prioritisation of topics for inclusion, based on an understanding of the wider landscape in the seafood supply chain.
- Provide input and guidance into the development of credible and implementable indicators for human rights in the ASC CoC Module, that balance the importance of the inclusion of human rights, with the reality of an acceptable and feasible burden for the certificate holders.
- Provide input into the development of guidance and capacity building materials to support certificate holders in their compliance with the ASC CoC Module.
- Consider options presented by ASC on verification mechanisms and provide a recommendation based on the options.

The expected deliverables from this process are:

- A clear recommendation on how to include human rights in the ASC CoC Module.
- A set of requirements on human rights for the ASC CoC Module.
- Guidance on how to implement and comply with the requirements.
- Capacity building and resources for certificate holders.

3. Membership

TWG membership shall focus on experts that are able to advise both on the approach for the module, and on the content and formulation of indicators. It will aim to balance interests, knowledge and experience from across seafood and broader work in human rights and include geographical representation. All members should support the aims of the ASC, its Vision and Mission, and commit to engage constructively.

3.1 Technical competencies required

The TWG shall include members with one or more of the following core competencies:

- Strong understanding of certification standard development, and social auditing.
- Understanding of and/or experience of the different parts of seafood production including processing and packing.
- Understanding of human rights risks across seafood.
- Ability to bring a rightsholder lens to the discussions.

3.2 Registered interests

ASC Technical Working Groups need to understand the interests of individual members to manage conflicts. Members are asked to declare these to ensure stakeholders and decision-makers have access to this information.

4. Reporting requirements

The TWG will report to the TAG on an annual basis. Output documents will be made available for review along with meeting minutes of the TWG meetings.

Materials made available for review will include:

- Meeting minutes
- Recommendations

5. Duration and review times

The TWG will be active until the approval of the revised indicators and complementary materials by the TAG. The TWG will meet regularly (online) and at key moments in the process as suggested in Table 1. The timeline and scope of each meeting will be further refined in consultation with the TWG at the first meeting. There is a possibility of reconvening the group after a year to review the progress.
